**Srinidhi Sekaran** joined V-Excel's Youth Empowerment Services (YES) in 2016 when she was 18. She had learning difficulties and was very docile. With a background in home science, she had a natural affinity for baking and kitchen activities in YES. Alongside, she was introduced to basic computer skills, data entry and even graphic designing. She learned all of this with great enthusiasm and followed instructions diligently. Her training was also extended to include front-office and communication skills.

After 2 years of focused training and with the support from her family, she was placed in Hotel Savera's baking unit. Despite the initial hiccups in the transition process, with immense support from the management in Savera and with hand-holding from our side, she settled well and flourished, until the pandemic derailed her career.



Srinidhi was home during the lockdown but actively participated in YES's online sessions. All her skills were fine-tuned and Srinidhi was given opportunities to attend job interviews. In the meantime, she interned at the bakery in Crowne Plaza.

It gives us immense pleasure and pride to share that, today, after going through the interviewing and selection process in Grundfos Pumps, Chennai, Srinidhi was selected to be part of their HR and Admin team. From all of us at V-Excel, we wish her a great future and success in all her future endeavours.

May her journey continue to be paved with successes and she will be an inspiration to all trainees in V-Excel and to the larger community.

# Towards Social Inclusion

Trainee Saravana Prabu S.K. from the Vocational Training Unit (VTU) in Adyar was hired as an intern at the Special Needs Empowerment Hub (SNEH). SNEH creates economic independence for adults with special needs by promoting products handcrafted by them and providing other sheltered employment opportunities.



Trainee Sriram Srinivasan, also from VTU, joined Grundfos Pumps Ltd., in the housekeeping department as an Intern. Prior to joining, he was trained to familiarize himself with the bus route of about 12 km.

Gokulakrishnan Subramani, an alumnus of the Youth Empowerment Services (YES) unit, is now a part of the Front Office in Hotel Crowne Plaza. He had lost his job during the pandemic.

Other trainees from YES included Srinidhi Sekaran who is now in Grundfos, Chennai. She had also been laid off during the pandemic. T..A Hari resumed his job in Blue Lagoon resort.

## **Platinum Award for Financial Transparency**

It gives us immense pleasure and happiness to share that V-Excel has, once again, been awarded the Guidestar India Platinum Certification for financial transparency. The award is valid until August 31, 2022.

This was a long and arduous process involving deep scrutiny of all our financial documents and transactions. The certification is a testament to our comprehensive transparency, accountability and good governance practices.

## **Customized training program for medical and para-medical professionals**

On August 26, V-Excel inaugurated a customized training program for medical and para-medical professionals, including Physio and Occupational Therapists, Speech and Language Therapists, and Senior Nurses from Lady Ridgeway Hospital and MJF Charitable Foundation, Sri Lanka. This is the first time a medical group has stepped forth to be trained in the holistic management of children with special needs, especially for Early Intervention for children in the Autism Spectrum. Their goal is to develop a community that can support young parents of children with special needs, medically, therapeutically and educationally. This 40-hour program was jointly funded by the Rotary Club of Colombo Reconnections and Rotary Club of Brisbane. V-Excel conducted this program as an academic partner of Inkle Weave Educational Training Services.



## **"New Beginnings"- Orientation for teachers of MCTM Chidambaram Chettyar School**

The first orientation session of 2021, named "New Beginnings", was held at the MCTM Chidambaram Chettyar School. This was very well received by the teachers of MCTM. Trainees at YES advocated for social inclusion. by making a collage of relevant quotes.





## World Letter Writing Day


September 1 is a day to celebrate hand-written letters and connections.





*Counselling has made a significant improvement to the way I interact with the world, and more importantly, with myself. I am in the process of unlearning many of the routine patterns of thought that once served me but are no longer contributing to my well-being. Interestingly, learning to place myself at the centre of my universe feels valid and long overdue in my journey to become more authentic to my own unique self. I have remarkably less episodes where I feel helpless or bound by the restrictions that society, community or I place on myself. In the areas that I'm unable to change, I'm learning to bide my time, let go or accept the situation for what it is. That, much of this has happened during the COVID pandemic amidst lockdowns is testament to the effectiveness of your counselling.*

*Manish, aged 3½, joined us for therapy and remedial interventions. He use to cry a lot during the first few sessions. I gave him the lock-chair and slowly he started sitting on doing activities. For the first three months, he only interacted with known persons like his therapist and special educator.*

*I was to work on his eye contact, so started showing pictures and objects keeping them at my eye level so that he could look at me. I sang action rhymes and he started enjoying them. I initiated action by pointing to the environmental objects and pictures. He made sound of animals and birds while singing rhymes. Slowly, he started recognizing the alphabets and numbers from 1 to 10 and said common picture names. Then he started telling days of the week and then months. He was also encouraged to imitate simple sentences.*

*Nowadays I am telling him the story - "The Blue Jackal" using story cards. He is trying to retell the story with prompts and is able to answer simple comprehension questions. He can identify numbers up to 50, and is able to interact with all the therapists, special educators, akkas and peers.*

*He has started writing alphabets in order and reading pictures. He also had some behavior issues like throwing objects, adamancy, touching his and others ears etc. After giving therapy activities like interactive play, focus and attention building activities there is a considerable reduction in his behavioral concerns.*
