Registration

Visit V-Excel's website and click on a webinar to register. Webinar registration closes 24 hours prior to the event. Registrants will receive an email immediately after registering for a webinar which will have the purchase confirmation with payment details

Joining the Webinar

Prior to the webinar, an email will be sent to all registrants with a unique join button to access the training. Clicking on the link in the email invitation will connect the registrant directly to the website, where you will view/listen to the webinar.

For optimal viewing, access the webinar using a computer with a high-speed internet connection and audio speakers. There is no software to be installed and the preferred and recommended browser of choice is Google Chrome.
